AN ORDINANCE ACCEPTING THE PROPOSAL OF THE CUYAHOGA COUNTY PLANNING COMMISSION TO CONDUCT THE NORTH ROYALTON 2006 REDISTRICTING STUDY, AND DECLARING AN EMERGENCY

WHEREAS: Pursuant to Article III, Paragraph (c) of the Charter of the city of North Royalton, a population study must be conducted every four years to determine the equalization of each Council Ward; and

WHEREAS: The Cuyahoga County Planning Commission has submitted a proposal in the amount of \$1,975.00 to perform this study; and

WHEREAS: Council desires to accept this proposal.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH ROYALTON, COUNTY OF CUYAHOGA AND STATE OF OHIO, THAT:

Section 1. Council hereby accepts the proposal submitted by the Cuyahoga County Planning Commission to conduct the 2006 North Royalton Redistricting Study in the amount of \$1,975.00, a copy of which is attached hereto and incorporated as if fully rewritten.

Section 2. The Mayor is hereby authorized to enter into a contract with the Cuyahoga County Planning Commission in a form approved by the Law Director.

Section 3. The Director of Legislative Services is hereby authorized and directed to forward a certified copy of this Ordinance to the Cuyahoga County Planning Commission.

Section 4. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 5. This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of the city, and for the further reason that Council has determined that it is immediately necessary to accept the proposal submitted by the Cuyahoga County Planning Commission to conduct the 2006 North Royalton Redistricting Study.

THEREFORE, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
