RESOLUTION NO. 07-6

INTRODUCED BY: Mayor Luks

A RESOLUTION DESIGNATING MICHAEL PISCITELLO TO ACT AS AGENT FOR AND LEAGUE DIRECTOR OF THE NORTH ROYALTON MEN'S SOFTBALL LEAGUES FOR THE 2007 SEASON, AND DECLARING AN EMERGENCY

- WHEREAS: The City of North Royalton Recreation Board is authorized to manage and control organized sports activities in the city; and
- WHEREAS: Presently, the North Royalton Baseball Boosters, who are authorized to act as the agent of the Recreation Board, operates the men's softball leagues and is in need of a person to manage the 35 & under, 35 & over, and 50 & over men's softball leagues; and
- WHEREAS: The city desires to contract with Michael Piscitello to act as agent for and League Director of the North Royalton Men's Softball Leagues.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NORTH ROYALTON, COUNTY OF CUYAHOGA AND STATE OF OHIO, THAT:

Section 1. Council concurs with and accepts the recommendation of the North Royalton Recreation Board that Michael Piscitello be recognized as the coordinator of the "North Royalton Men's Softball Leagues" for the 2007 season, which includes the following leagues: 35 & under, 35 & over, and 50 & over. The Mayor is authorized to execute an agreement with Mr. Piscitello in substantially the same form as Exhibit A, attached hereto and incorporated herein by reference.

Section 2. Mr. Piscitello is hereby designated as an official agent of the North Royalton Recreation Department, and as such is authorized to collect fees, arrange programs, and schedule fields for all amateur men's softball activities in the city, subject to the approval of the North Royalton Recreation Board (the NRRB).

Section 3. Mr. Piscitello, the baseball coordinator, shall be under the control and direction of the NRRB and shall operate said leagues within the budget as approved by the NRRB. He shall comply with the requirements of the Finance Director and shall report income and expenses to the Finance Director and NRRB on a monthly basis, providing copies of all receipts and all canceled checks to the Finance Director.

Section 4. All funds collected will be used to improve the recreation facilities in the City of North Royalton and to operate the "North Royalton Men's Softball Leagues."

Section 5. Mr. Piscitello shall comply with all criteria set forth in "Exhibit A," attached hereto, to operate the "North Royalton Men's Softball Leagues" for the 2007 softball season ending October 31, 2007.

Section 6. The Recreation Director shall be responsible for providing the necessary fields and facilities for the operation of the baseball activities.

Section 7. The Recreation Director is hereby authorized and directed to work in harmony with the coordinator to insure the continued success of this excellent program.

Section 8. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 9. This Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of the City, and for the further reason that Council desires to provide the Recreation Board of North Royalton with this official administrative agent.

THEREFORE, provided this Resolution receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
