

AGREEMENT

This Agreement is entered into this ___ day of March, 2008, by and between the City of North Royalton (hereinafter "the City"), being a municipal corporation in and political subdivision of the State of Ohio ("State") and duly organized and validly existing under the Constitution and Laws of the State and Donna M. Vozar, an attorney at law licensed in the State of Ohio and in good standing with the Ohio State Bar Association (hereinafter "the First Assistant").

WHEREAS, Section 236.02 of the Codified Ordinances of the City of North Royalton specifies that the position of First Assistant prosecutor shall be an appointive one and it is the desire of Council, in addition to the North Royalton Charter provisions, to have a contractual relationship with the First Assistant prosecutor which will cover such matters as compensation, duties, termination of contract and other matters of like nature; and

WHEREAS, the Mayor has appointed Donna M. Vozar as First Assistant Prosecutor.

IT IS THEREFORE MUTUALLY AGREED BETWEEN THE PARTIES AS FOLLOWS:

That Donna M. Vozar shall serve as First Assistant Prosecutor of the City for the term of office of Mayor Robert A. Stefanik that commenced on or about November 26, 2007. This agreement shall expire at the end of the Mayor's term of office when a successor has been appointed and commences performance or earlier upon termination as specified below.

The First Assistant Prosecutor shall assist the Law Director and Prosecutor in prosecuting all criminal violations of City ordinances and State statutes in the Mayor's Court and courts of record, in addition to prosecution of violations of the Building Code, the Zoning Code, Sanitary Sewer and Sewer Rental Charge ordinances, the Municipal Income Tax ordinances, giving advice to residents, conducting prosecutor's hearings, hearing and reviewing complaints of all enforcement officials of the City and such other duties as may from time to time be required by the Law Director or Mayor.

For services outlined above, the First Assistant Prosecutor shall receive a retaining fee *in an amount as provided by Ordinance of Council* of ~~\$30,000 per annum (calendar year)~~ and shall have the option of receiving healthcare benefits to include medical, dental and eye care, the premiums which shall be fully paid for by the City. The retaining fees shall be paid on a monthly basis commencing upon the effective date of this agreement and the amounts shall be subject to the contribution by the First Assistant Prosecutor to OPERS.

The First Assistant may terminate this agreement upon service to the Law Director and Mayor a written notice of termination not less than sixty (60) days prior to the effective date of termination.

The City may terminate this agreement, without cause, upon serving written notice to the First Assistant at his office or home address not less than sixty (60) days prior to the effective date of said termination and by obtaining official concurrence of two-thirds (2/3) of the Members of City Council and approval of the Mayor.

This agreement shall be construed and governed by Ohio law.

IN WITNESS WHEREOF, the Parties have executed this Agreement on the aforementioned date in the City of North Royalton, County of Cuyahoga, Ohio.
