AN ORDINANCE ACCEPTING THE BID OF VALLEY FREIGHTLINER TRUCKS OF CLEVELAND FOR THE PURCHASE OF ONE (1) 2009 SINGLE AXLE DUMP TRUCK CHASSIS FOR THE SERVICE DEPARTMENT FOR AN AMOUNT NOT TO EXCEED \$63,856.00 AS THE LOWEST AND BEST BID, AND DECLARING AN EMERGENCY

WHEREAS: Council has authorized the purchase of a dump truck chassis for the North Royalton Service Department; and

WHEREAS: The city has advertised for competitive bids for this equipment; and

WHEREAS: It has been determined that the bid of Valley Freightliner of Cleveland for the purchase of one (1) 2009 single axle dump truck chassis for an amount not to exceed \$63,856.00 is the lowest and best bid; and

WHEREAS: Council desires to accept this bid.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH ROYALTON, COUNTY OF CUYAHOGA AND STATE OF OHIO, THAT:

Section 1. Council hereby accepts the bid of Valley Freightliner Trucks of Cleveland for the purchase of one (1) 2009 single axle dump truck chassis for an amount not to exceed \$63,856.00 for the Service Department, and as further described in Exhibit A attached hereto and incorporated as if fully rewritten.

Section 2. The Mayor is hereby authorized to enter into a contract with Valley Freightliner of Cleveland in a form approved by the Law Director.

Section 3. The Service Department is hereby authorized and directed to forward a certified copy of this Ordinance to Valley Freightliner of Cleveland, and all certified checks and bonds are hereby authorized to be returned to the unsuccessful bidders.

Section 4. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 5. This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of the city, and for the further reason that it is immediately necessary to provide for the purchase of this vehicle for the North Royalton Service Department for the proper and immediate performance of departmental duties.

THEREFORE, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
