AN ORDINANCE AMENDING ORDINANCE 09-38 WHICH AUTHORIZED THE EXPENDITURE OF FUNDS FOR THE PURCHASE OF ONE (1) 2009 INTERNATIONAL 7500 CHASSIS-CAB FOR THE SERVICE DEPARTMENT THROUGH THE OHIO DEPARTMENT OF TRANSPORTATION PURCHASING CONTRACT FOR AN AMOUNT NOT TO EXCEED \$81,478.00, AND DECLARING AN EMERGENCY

WHEREAS: Council previously adopted Ordinance 09-38 authorizing the purchase of a 2009 International 7500 Chassis-Cab for the North Royalton Service Department through the Ohio Department of Transportation Purchasing Contract; and

WHEREAS: When placing the order for this vehicle, the Service Department was able to acquire a 2010 model year vehicle for the same price as a 2009; and

WHEREAS: It is therefore necessary to amend Ordinance 09-38 to indicate that this vehicle will be a 2010 model year vehicle instead of a 2009; and

WHEREAS: It is necessary to provide for the funding of said purchase.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH ROYALTON, COUNTY OF CUYAHOGA AND STATE OF OHIO, THAT:

Section 1. The title and Section 1 of Ordinance 09-38 are hereby amended to read as follows:

AN ORDINANCE AUTHORIZING THE EXPENDITURE OF FUNDS FOR THE PURCHASE OF ONE (1) ~~2009~~ **2010** INTERNATIONAL 7500 CHASSIS-CAB FOR THE SERVICE DEPARTMENT THROUGH THE OHIO DEPARTMENT OF TRANSPORTATION PURCHASING CONTRACT FOR AN AMOUNT NOT TO EXCEED \$81,478.00, AND DECLARING AN EMERGENCY

Section 1. Council hereby authorizes the expenditure of an amount not to exceed \$81,478.00 for the purchase of one (1) ~~2009~~ **2010** International 7500 Chassis-Cab for the Service Department pursuant to ODOT Contract No. 023-09 awarded to vendor: Miami Valley International Trucks, Inc., 11775 Highway Drive, Cincinnati, OH 45241, Vendor #31-1040091, and as further described in Exhibit A attached hereto and incorporated as if fully rewritten.

Section 2. The Service Director is hereby authorized and directed to forward a certified copy of this Ordinance to Miami Valley International Trucks, Inc.

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 4. This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of the city, and for the further reason that it is immediately necessary to amend Ordinance 09-38 in order to allow for the purchase of a 2010 model year vehicle.

THEREFORE, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
