

AN ORDINANCE AMENDING THE CODIFIED ORDINANCES OF THE CITY OF NORTH ROYALTON,
PART 6 GENERAL OFFENSES CODE, CHAPTER 630 GAMBLING, SECTION 630.01 DEFINITIONS,
AND DECLARING AN EMERGENCY

WHEREAS: It has been determined to be necessary to amend the Codified Ordinances of the City of North Royalton, Part 6 General Offenses Code, Chapter 630 Gambling, Section 630.01 Definitions to include definitions for “Computerized Sweepstakes Device” and “Sweepstakes Terminal Café”; and

WHEREAS: Council desires to provide for these amendments.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH ROYALTON,
COUNTY OF CUYAHOGA AND STATE OF OHIO, THAT:

Section 1. Part 6 General Offenses Code, Chapter 630 Gambling, Section 630.01 Definitions of the Codified Ordinances of the City of North Royalton, Paragraph (u) is hereby amended by creating a new subparagraph (6) which shall hereinafter read as follows:

- (u) "Gambling device" means any of the following:
 - (6) *computerized sweepstakes device*

Section 2. Part 6 General Offenses Code, Chapter 630 Gambling, Section 630.01 Definitions of the Codified Ordinances of the City of North Royalton, is hereby amended by creating new Paragraphs (iii) and (jjj) which shall hereinafter read as follows:

(iii) “Computerized sweepstakes device” means any computer, machine, game or apparatus which, upon the insertion of a coin, token or similar objected, or upon payment of anything of value, wherein a product or service is provided, and may be operated by the public generally for use as a contest of skill or chance, entertainment or amusement, whether or not registering a score.”

(jjj) “Sweepstakes Terminal Café” means any premises upon which any computerized sweepstake device is located for the use or entertainment of the public, whether or not such premises has any other business purpose.

Section 3. Chapter 630 Gambling, Section 630.01 Definitions of the Codified Ordinances of the City of North Royalton, is hereby amended as provided for herein and all other provisions of Chapter 630 shall remain in full force and effect.

Section 4. This Ordinance shall supersede all previously adopted Ordinances in direct conflict herewith.

Section 5. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 6. This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of the city, and for the further reason that it is immediately necessary to amend the Codified Ordinances of the City of North Royalton, Part 6 General Offenses Code, Chapter 630 Gambling, Section 630.01 Definitions to include definitions for “Computerized Sweepstakes Device” and “Sweepstakes Terminal Café”.
