

# THE CITY COUNCIL OF NORTH ROYALTON, OHIO

ORDINANCE NO. 10-152

AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A GRANT AGREEMENT WITH NOPEC, INC. IN THE AMOUNT OF \$60,000 TO FUND THE REPLACEMENT OF FOUR EXISTING AIR COOLED CONDENSING UNITS AND ONE PACKAGED ROOFTOP UNIT FOR THE NORTH ROYALTON POLICE STATION AND RATIFYING SAME, AND DECLARING AN EMERGENCY

WHEREAS: The City of North Royalton applied for a Powering Our Communities (POC) grant award; and

WHEREAS: Said award was approved by the NOPEC, Inc. POC Grants Review Committee; and

WHEREAS: This grant money will be used to fund the replacement of four existing air cooled condensing units and one packaged rooftop unit for the North Royalton Police Station; and

WHEREAS: Council wishes to authorize the Mayor to enter into this agreement and ratify same.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH ROYALTON, COUNTY OF CUYAHOGA AND STATE OF OHIO, THAT:

Section 1. Council hereby authorizes the Mayor to enter into a grant agreement and ratify same with NOPEC, Inc. in the amount of \$60,000 to fund the replacement of four existing air cooled condensing units and one packaged rooftop unit for the North Royalton Police Station pursuant to terms and conditions approved by the Director of Law and substantially similar to a copy of which is attached hereto as Exhibit A and incorporated as if fully rewritten.

Section 2. This Ordinance shall supersede all previously adopted Ordinances in direct conflict herewith.

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 4. This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of the city, and for the further reason that it is immediately necessary to authorize the Mayor to enter into a grant agreement with NOPEC, Inc. in the amount of \$60,000 to fund the replacement of four existing air cooled condensing units and one packaged rooftop unit for the North Royalton Police Station.

THEREFORE, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
