ORDINANCE 06-107

AN ORDINANCE TO AMEND SECTIONS 880.01, 880.03, 880.04, 880.17, 880.20, 880.26, AND 880.27 OF CHAPTER 880 OF THE CODIFIED ORDINANCES OF THE CITY OF NORTH ROYALTON, OHIO, IN ORDER TO PROVIDE FOR A ONE PERCENT INCREASE IN THE CURRENT LEVY ON INCOME, TO A RATE OF TWO PERCENT EFFECTIVE JANUARY 1, 2007, FOR THE PURPOSES OF PAYING COSTS OF CONSTRUCTING, RECONSTRUCTING, WIDENING, GRADING, DRAINING, PAVING, RESURFACING, MAINTAINING, REPAIRING, AND OTHERWISE IMPROVING STREETS, SIDEWALKS, CURBS AND GUTTERS, AND RELATED INFRASTRUCTURE IMPROVEMENTS, COSTS OF CONSTRUCTING AND INSTALLING STORM WATER IMPROVEMENTS, COSTS OF ACQUIRING RELATED EQUIPMENT AND OTHER RELATED MUNICIPAL STREET AND STORM WATER OPERATING EXPENSES AND GENERAL MUNICIPAL FUNCTIONS OF THE CITY, AND TO INCREASE THE MUNICIPAL INCOME TAX CREDIT TO 100% OF THE AMOUNT OF MUNICIPAL INCOME TAX PAID TO ANOTHER MUNICIPALITY ON THE SAME INCOME TAXABLE UNDER CHAPTER 880 OF THE CODIFIED ORDINANCES OF THE CITY UP TO 1.25%, WITH NO REDUCTIONS IN THE TAX CREDIT PERMITTED WITHOUT THE APPROVAL OF THE ELECTORS OF THE CITY AS PROVIDED HEREIN, AND DECLARING AN EMERGENCY. Title read.

Moved by Mr. Gentile, seconded by Mr. Willey to **reconsider the motion to adopt Ordinance 06-107 as amended**. Roll Call: Yeas: **Seven** (Stefanik, Bobulsky, Gentile, Willey, McKee, Antoskiewicz, Uffman-Kirsch). Nays: **None. Motion carried**.

Mr. Stefanik announced that Ordinance 06-107 is back in front of Council in it's amended state from July 18, 2006. He asked if there were any proposed amendments to 06-107.

Legislative Services Director Laura Haller read the following statement:

After listening to the tape of the July 18, 2006, Council meeting, it was discovered that I (Laura Haller) read the wrong sentence in the title when proposing the amendments we made on July 18, 2006. The legislation was amended correctly, I simply read the wrong sentence. As a measure of caution, I would like to revisit the amendment to the title of this legislation. (Ordinance 06-108, which contained Ordinance 06-107 in its entirety as a part of its contents was read and amended correctly on July 18, 2006.)

Therefore the following amendment to Ordinance 06-107 was proposed:

AN ORDINANCE TO AMEND SECTIONS 880.01, 880.03, 880.04, 880.17, 880.20, 880.26, AND 880.27 OF CHAPTER 880 OF THE CODIFIED ORDINANCES OF THE CITY OF NORTH ROYALTON, OHIO, IN ORDER TO PROVIDE FOR A ONE PERCENT INCREASE IN THE CURRENT LEVY ON INCOME, TO A RATE OF TWO PERCENT EFFECTIVE JANUARY 1, 2007, FOR THE PURPOSES OF PAYING COSTS OF CONSTRUCTING, RECONSTRUCTING, WIDENING, GRADING, DRAINING, PAVING, RESURFACING, MAINTAINING, REPAIRING, AND OTHERWISE IMPROVING STREETS, SIDEWALKS, CURBS AND GUTTERS, AND RELATED INFRASTRUCTURE IMPROVEMENTS, COSTS OF CONSTRUCTING AND INSTALLING STORM WATER IMPROVEMENTS, COSTS OF **ACQUIRING RELATED EQUIPMENT AND OTHER** (this "other" incorrectly read as the amendment at the July 18, 2006 meeting) **RELATED MUNICIPAL STREET AND STORM WATER OPERATING EXPENSES AND OTHER** (this "other is the word that is to be deleted) **GENERAL MUNICIPAL FUNCTIONS OF THE CITY**, AND TO INCREASE THE MUNICIPAL INCOME TAX CREDIT TO 100% OF THE AMOUNT OF MUNICIPAL INCOME TAX PAID TO ANOTHER MUNICIPALITY ON THE SAME INCOME TAXABLE UNDER CHAPTER 880 OF THE CODIFIED ORDINANCES OF THE CITY UP TO 1.25%, WITH NO REDUCTIONS IN THE TAX CREDIT PERMITTED WITHOUT THE APPROVAL OF THE ELECTORS OF THE CITY AS PROVIDED HEREIN, AND DECLARING AN EMERGENCY.

Moved by Mr. Willey, seconded by Mr. Gentile to **amend Ordinance 06-107 as read**. Roll Call: Yeas: **Seven** (Stefanik, Bobulsky, Gentile, Willey, McKee, Antoskiewicz, Uffman-Kirsch). Nays: **None. Motion carried.**
