RESOLUTION 07-3

Introduced by: Mayor Luks. **A RESOLUTION ADOPTING THE UPDATED COUNTYWIDE ALL NATURAL HAZARDS MITIGATION PLAN FOR CUYAHOGA COUNTY, AND DECLARING AN EMERGENCY.** Title read.

Based on a letter received today by the Mayor from Michael Goodwin of Cuyahoga County Emergency Management, the Director of Legislative Services read the following proposed amendments:

TITLE: A RESOLUTION ADOPTING THE ~~UPDATED~~ **REVISED 2007 VERSION OF THE** COUNTYWIDE ALL NATURAL HAZARDS MITIGATION PLAN FOR CUYAHOGA COUNTY, AND DECLARING AN EMERGENCY

Section 4. This Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of the City, and for the further reason that Council has determined that it is immediately necessary to adopt this ~~updated~~ **revised** plan pursuant to the Disaster Mitigation Act of 2000 which requires all communities that desire to apply for mitigation programs to have an all natural hazards mitigation plan.
