ORDINANCE NO. 12-139

INTRODUCED BY: Mayor Stefanik

AN ORDINANCE RECOGNIZING A SURPLUS IN THE CLERK OF COURTS COMPUTER SERVICES FUND, EXTENDING THE PURPOSE FOR WHICH THOSE FUNDS MAY BE EMPLOYED, AUTHORIZING THE MAYOR TO EMPLOY SAID FUNDS TO PROVIDE SUCH ANCILLARY EQUIPMENT, OFFICE SPACE, FURNITURE AND OTHER TECHNOLOGICAL SUPPORT AS IS NECESSARY AND/OR APPROPRIATE FOR THE EFFICIENT OPERATION OF SAID COURT, AND DECLARING AN EMERGENCY

WHEREAS: Pursuant to Ordinance 97-210, the Clerk of Courts Computer Services Funds was established to provide a fund solely to purchase computers for the office of the Clerk of the Mayor's Court; and

WHEREAS: The Mayor and Council recognize a surplus in said funds; and

WHEREAS: The cost of computers has diminished significantly since the creation of said fund; and

WHEREAS: The office of the Clerk of Court has other additional and pressing needs for modified office space, furniture, ancillary equipment and other technological support.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH ROYALTON, COUNTY OF CUYAHOGA AND STATE OF OHIO, THAT:

Section 1. The Clerk of Courts Computer Services Fund shall be used to provide computer services (including but not limited to computers, display screens, hard drives, software, printers, and other technological equipment and future similar technology), office space for the operation of said equipment, desks, furniture and such other ancillary improvements/equipment as is/are necessary and/or appropriate for the efficient operation of said Court.

Section 2. This Ordinance shall supersede all previously adopted ordinances in direct conflict herewith.

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 4. This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of the city, and for the further reason that it is immediately necessary for the efficient operation of and appropriate facilities and support for the office of the Clerk of the Mayor's Court.

THEREFORE, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise from and after the earliest period allowed by law.
