

# THE CITY COUNCIL OF NORTH ROYALTON, OHIO

ORDINANCE NO. 12-150

AN ORDINANCE APPROVING THE CUYAHOGA COUNTY SOLID WASTE DISTRICT SOLID WASTE MANAGEMENT PLAN UPDATE (2013-2028), AND DECLARING AN EMERGENCY

WHEREAS: The City of North Royalton is located within the jurisdiction of the Cuyahoga County Solid Waste Management District; and

WHEREAS: The Cuyahoga County Solid Waste Management District Policy Committee prepared and adopted a final draft of the Solid Waste Management Plan in accordance with Ohio Revised Code Sections 3734.53, 3734.54 and 3734.55; and

WHEREAS: The District provided a copy of the Cuyahoga County Solid Waste Management Plan Update (2013-2028) for ratification to each of the legislative authorities of the District; and

WHEREAS: The City of North Royalton must decide whether it approves of said Solid Waste Management Plan no later than November 17, 2012.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH ROYALTON, COUNTY OF CUYAHOGA AND STATE OF OHIO, THAT:

Section 1. The City of North Royalton approves the Cuyahoga County Solid Waste Management Plan Update (2013-2028).

Section 2. The Director of Legislative Services is hereby directed to send the District a copy of this Ordinance to the attention of Diane T. Bickett, Executive Director, Cuyahoga County Solid Waste Management District, 4750 E. 131 St., Garfield Hts., Ohio 44105.

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 4. This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of the city, and for the further reason that it is immediately necessary to approve the Cuyahoga County Solid Waste Management Plan Update (2013-2028) as required by Ohio Law.

THEREFORE, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise from and after the earliest period allowed by law.
